### **Voting is underway for the June 24 Primary Election**

*Return your ballot with 70 cents postage or to one of 20 drop-off locations*

**Littleton, CO** – Ballots are arriving in mailboxes for the Arapahoe County June 24 Primary Election. Voters can return their ballot by mail with 70 cents postage, or deliver it to one of [20 drop-off locations](#) around the county, including six 24-hour drop boxes. Find a ballot box near you at [www.arapahoevotes.com](http://www.arapahoevotes.com).

An affiliated voter who has not received a ballot by Monday, June 9 should contact the Arapahoe County Elections Division at 303-795-4511 to request a replacement ballot.

Four [Voter Service and Polling Centers](#) opened June 2 in Aurora, Byers, Centennial and Littleton to provide in-person voter services through Election Day. Citizens may visit these locations to register to vote in-person, update their voter record, request or replace a ballot, or vote on an accessible voting machine.

Voters will only receive a Primary Election ballot if they are affiliated with the American Constitution, Democratic or Republican parties. Voters in these participating parties will be deciding which candidates from their party will appear on the Nov. 4 General Election ballot.

The deadline has passed for affiliated voters to change their party affiliation for the Primary Election. However, unaffiliated voters who wish to vote in the Primary Election may affiliate through Election Day. It also is not too late to register to vote or update a voter registration. Voters may do so online through June 16 at [www.govotecolorado.com](http://www.govotecolorado.com), or in-person at a Voter Service and Polling Center through Election Day.

Inactive voters will not automatically receive a mail ballot. In order to reactivate a voter registration record and request a ballot, please call the Elections Division at 303-795-4511.
