## **Arapahoe County Assessor Corbin Sakdol appointed by Gov. Hickenlooper to statewide advisory committee**

*Sakdol appointed to serve a four-year term on the Statutory Advisory Committee to the State of Colorado Property Tax Administrator*

LITTLETON, CO --- On Oct. 6, Arapahoe County Assessor Corbin Sakdol was appointed by Gov. John Hickenlooper to serve on the Statutory Advisory Committee to the Property Tax Administrator.

Sakdol, who has 25 years of assessment experience and has been Arapahoe County Assessor's since 2007, is one of five members appointed by the Governor to serve a four-year term on the committee, which makes recommendations to the State Board of Equalization.

The Statutory Advisory Committee to the Property Tax Administrator has the authority to review and make recommendations to the State Board of Equalization to approve or disapprove manuals, appraisal procedures, instructions, guidelines, forms, notices, records published, approved or prescribed before they are presented to the Legal Services Committee and published by the Administrator.

"It is an honor to be asked to participate in this statewide committee based on my experience and qualifications," Sakdol said. "I look forward to working with my colleagues from counties throughout the state and the Property Tax Administrator to provide best practice procedures for the assessment community while always keeping in mind what is best for the citizens we work for."

In September, the Assessor's Office passed the 2014 Property Assessment Study, by meeting and exceeding all standards set by the State Board of Equalization. Under Sakdol's leadership, the Assessor's Office has passed every annual state audit.

Sakdol has more than 33 years of real estate, business and technology experience, including working in the Arapahoe County Assessor's Office since 1990. He is a licensed Certified General Appraiser and was a licensed Real Estate Broker for more than 20 years. He has a degree in Architectural Technology.

Sakdol is President of the Colorado Assessors' Association, which represents Colorado's 64 counties and in 2012 was unanimously named Colorado Assessor of the Year by his peers.
