Redemption Interest:

The Federal Reserve discount rate as of September 1, 2020 was a quarter of a percent (.25%); therefore, Certificates of Purchase sold at the 2020 Tax Lien Sale will carry the rate of nine percent (9%) in accordance with Section 39-12-103, C.R.S.
